7.30pm The Chairman welcomed those present and opened the meeting.

- 1. **Apologies for absence:** Cllr Gillian Crossley-Holland and Cllr Rosemary Jones.
- 2. Casual Vacancies in the Office of Parish Councillor: None.
- 3. **To confirm the minutes of the Meeting held on 3 March 2016:** The minutes of the meeting were agreed and signed.
- 4. Magazine Input: Cllr Smith.
- 5. **Members Declarations of Interest and Dispensations:** None.
- 6. **Public Forum:** 7.34pm RESOLVED, with all in favour, to adjourn the meeting for the public forum. *There were no members of the public who wished to speak.* The Chairman reconvened the meeting at 7.35pm.

7. **Planning:**

- 7.1 **Planning Applications:** None.
- 7.2 **Notice of Intent works to tree(s) in the Conservation Area:** None.
- 7.3 Notification of Planning Decisions by Mid Suffolk DC:
- 7.3.1 Willowmere, Garden House Lane, Rickinghall Superior. Ref: 4116/15. Jubilee House, The Street, Rickinghall Inferior. Ref: 0009/16. Proposed residential development of 3 houses with detached 3 bay cart-lodge, construction of new site access and cart-lodge to existing dwelling. WITHDRAWN.
- 7.3.2 **Suggen Hall Farm, Church Lane, Rickinghall Superior.** Ref: 0189/16. Retention of static caravan on site for occupation by the owner's family during the major restoration of house. Planning Permission GRANTED.
- 7.3.3 **The Walk, Garden House Lane, Rickinghall Superior.** Ref: 0538/16. Erection of detached 3 bedroom dwelling with integrated garage following demolition of existing garage with associated vehicular access to serve The Walk and proposed dwelling. Planning Permission GRANTED.

8. **Progress Reports:**

- 8.1 **Chairman:** The Chairman would write to local councils to introduce the new community bus arrangements and discuss funding.
- 8.2 **Clerk:** The Clerk reported that the full report from the traffic survey would be available online by early May.

9. **Correspondence:**

- 9.1 Suffolk Constabulary: It was noted that Suffolk Constabulary had undertaken a review of local policing and changes had been made. There would no longer be a regular police presence at parish council meetings but they would attend where there was a specific issue that required discussion and would attend Annual Parish Meetings where possible. There would be a new form of monthly reports which would cover the whole of the SNT area (Stowmarket) rather than just the would be available on the Constabulary parish, and www.suffolk.police.uk.
- 9.2 **MSDC:** The Town and Parish Council Newsletter was noted.

9.3 **UK Power Networks:** It was noted that UK Power Networks provided a free Priority Services Register for those who needed more support in the event of a power cut, e.g. residents with a disability, were blind or visually impaired, were chronically sick, dependent on medical equipment or had young babies. It was agreed to put contact information in the parish magazine.

10. General Items:

- 10.1 **Street Lighting:** The PC considered the cost of replacing of aging lights, totalling over £23,000 and received advice to replace light no. 57 as it had not been working for several months. The options were to replace it in (£995) or out (£1,994) of G39 (within 1.5m of live cable) and it was RESOLVED, with all in favour, to replace it out of G39 in case future contractors were not able to work with G39 equipment. It was agreed to write to Jubilee House to notify them that the replacement post would have be on the other side of their drive.
- 10.2 **Payment of Grant funding:** The Council RESOLVED, with all agreed, to make the following payments from its 2016/17 budget, leaving a balance of £205:

Rickinghall Day Centre £ 300 s137 LGA 1972

Royal British Legion £ 65 s137 LGA 1972 (wreath)

Botesdale & Rickinghall NHW £ 30 s137 LGA 1972

It was noted that funding for the Remembrance Ceremony and wreath would be paid closer to the date and other grants paid in May.

- 10.3 **Byelaws and Public Nuisance:** The PC noted the report from the Clerk on tools for dealing with inconsiderate behaviour such as dog fouling and parking issues. A long article on dog fouling would be in the next parish magazine.
- 10.4 **Neighbourhood Plan:** Botesdale PC had contacted the PC concerning the possibility of drafting a joint Plan as there were new sources of funding and advice available now. Councillors questioned whether it was a good time to start given the current push for devolution and the uncertainty of future local government. It was also noted that the Plan was a significant amount of work and there was a requirement for it to be community led. It was agreed to make people generally aware of the demand for new housing in the community and see if the upcoming results of the land bid would generate interest in a Plan.
- 10.5 **Dog Bin:** The PC considered putting a dog bin near the church on the south side of the bypass but deferred a decision pending further investigation of need.
